The following points were discussed in the meeting:

1. Posters, awareness drives and student orientation programmes were evaluated for their visibility and impact on student awareness.
2. Initial feedback suggests that orientation sessions were informative, but the reach of posters in less frequented areas needs improvement.
3. New students found the campus environment welcoming with minimal discomfort during initial interactions.
4. The complaint/suggestion box was reviewed, revealing a few anonymous entries expressing general anxiety rather than specific incidents.
5. Surprise inspections were carried out in hostels, canteens and common areas to ensure compliance with anti-ragging norms.
6. Regular unannounced inspections will be carried out to maintain vigilance and student safety.
7. Digital materials, short reminder videos and email campaigns are being planned for broader awareness.
